### Rules:

- 1) Must be officially entered to participate.
- 2) Children are asked to bring their own poles, bait & 5-gallon bucket.
- 3) One each, per child, of line, hook & pole in water at one time.
- 4) Each entrant must cast & reel in their fish to the bank.
- 5) **The only help allowed is to bait the hook or take the fish off the hook after it is landed.**
- 6) Child to bring fish to check-in as they are caught, one at a time, in their 5-gallon bucket.
- 7) No fishing nets OR fishing stringers are allowed.
- 8) Participants receiving additional help will be disqualified.
- 9) Fishing will be allowed in designated areas only.
- 10) Children must be accompanied by an adult at all times.
